#### **COURSE DESCRIPTION**

This training course provides participants with a basic overview of knowledge areas covered by the Maryland Nutrient Management Certification Examination. Topics include state nutrient management regulations, nutrient management principles, basic soil science, and soil fertility recommendations. Instructors are university and government experts.

The Certification Examination will be held on Friday, August 2, 2024. Study materials for the exam will be distributed at the training session. #### **DIRECTIONS**

#### From Baltimore:

Take I-97 toward Annapolis. Continue until I-97 merges into US 50 East. Take the first exit, #22 (MD 665) to Riva Road. Turn right on Riva Road and continue for two lights to Harry S. Truman Parkway. Turn right and proceed one-half mile to MDA headquarters on the right.

# From Washington:

Take US 50 toward Annapolis. Take Exit 22 (MD 665) to Riva Road. Turn right on Riva Road and continue for two lights to Harry S. Truman Parkway. Turn right and proceed one-half mile to MDA headquarters.

# From the Eastern Shore:

Take US 50 to Exit 22 (MD 665) to Riva Road. Turn right on Riva Road and continue for two lights to Harry S. Truman Parkway. Turn right and proceed one-half mile to MDA headquarters.
